- Independent Audit Chairman Tobias stated that he has been in contact with PSATS and has received possible auditors' information. Stated that he will table the action until the next meeting.
- Beavers on Erickson Rd. Chairman Tobias contacted the Game Commission and will contact Ron Hillyard to see if Derek Hamilton is trapping them.
- Tax Collector Resolution Supervisor Freeman made a motion to adopt the Resolution. There was no second. Tabled by Chairman Tobias for next month.
- Appointment of Township Roadmaster- Chairman Tobias nominated Supervisor Erickson.
 Supervisor Erickson seconded. All in favor. Motion carried.

NEW BUSINESS:

- County Liquid Fuels distribution for 2021 in the amount of \$2102.76. Motion made by Supervisor Erickson to use the funds for limestone, second by Supervisor Freeman. All in favor. Motion carried.
- Equipment repairs and replacement. JD needs repaired and the Ford 550 needs to be replaced. Discussion followed. Chairman Tobias stated that we need to get repair estimates for the John Deere. Will have the Road Foreman get both repair and replacement estimates for both.
- Steam Genie purchase. May have been approved in a previous meeting. Discussion followed. Road Foreman will get quotes for this also. Will discuss next meeting.
- Invoice of Tax Collector's membership in Pa Tax Collectors' Association. Motion made by Supervisor Freeman to approve this. Second by Supervisor Erickson. All in favor. Motion carried.
- Ivan Lehman representing Northeastern Potter Economic Development Association spoke regarding their efforts to remove or improve blighted properties in our area with a resolution or ordinance giving the owners of said properties tax incentives. The Supervisors appreciated Mr. Lehman's presentation and will read the information he provided. They will bring this matter to the Township's Solicitor and discuss at the March meeting at which point they will contact Mr. Lehman with any questions or a decision on this matter.

CORRESPONDENCE:

Secretary Moon presented two new pieces of correspondence:

- Letter from Sucevic, Piccolomini & Kuchar Engineering about PennDot replacing a structure that carries SR449 over Pine Creek
- Letter from DEP regarding Preston Hoopes Sewage Planning Exemption Request.
