# ULYSSES TOWNSHIP SUPERVISORS REGULAR MONTHLY MEETING July 14, 2021

The Ulysses Township Supervisors met for their regular monthly meeting held on the above advertised date at the Ulysses Twp. Municipal Building at 7:00p.m. The following were present: Chairman Richard Tobias, Supervisor Daniel Freeman, Supervisor Richard Erickson, Secretary Moon. Guest(s) present were: Dean Boorum representing JKLM Energy.

Chairman Tobias called the meeting to order at 7p.m. and stated that the meeting was being recorded. Supervisor Erickson made a motion to approve the minutes of the June 2021 meeting. Chairman Tobias seconded. All in favor. None opposed. Motion carried.

## PUBLIC COMMENT:

Mr. Boorum stated that the ditches on Nauman Rd. have been cleaned and road has been graded.

## **ROAD FOREMAN REPORT:**

- Grading has been completed on all roads except. Newfield, Ellis, Kidney, Horseshoe, and Rooks. They are currently on Rooks which is about one-half finished.
- They have repaired potholes on Telescope, Kidney, and Cowburn Rd.
- Horseshoe Rd. project is still on hold until first round of road grading is completed. Should be starting by the end of July.
- All Equipment is up and running. The Freightliner is getting inspected on 07/15. Volvo and trailer are getting inspected next week.
- Cost estimate is \$3400 to \$3600 to have Tom Nelson repair the front axles on the Freitghtliner. Other estimate was much higher. Tom Nelson will be doing the repairs.
- There is an ATV sign on Rooks Rd. is now back up. There is a stop sign on the corner of Cowburn Rd. and Fox Hill Rd. that needs repaired. There is an ATV weight limit sign on Cushing Hollow Rd. that needs to be put back.
- Chairman Tobias is going to contact Ron Hillyard regarding the beavers on Erickson Rd.

### **OLD BUSINESS:**

• Telescope Rd. Bridge repair - Chairman Tobias talked to the Conservation District whio believes the Permit should be here by the beginning of next week. He will then contact LC Whitford to

start staging the project. Supervisor Freeman questioned the funding for this project. Chairman Tobias stated that a grant has been applied for.

- Road Foreman Pension Plan Chairman Tobias is waiting for additional information. Supervisor Freeman wondered if we could check and see if anyone else in the area is providing a pension plan for their foreman. Mr. Tobias said the Township is looking at one through PSATS.
- Progress on Township website the website is up. The link is ulyssestownship.com.

#### **NEW BUSINESS:**

 Reclaiming of the segments along Route 6 near the old Sylvania Restaurant. Chairman Tobias explained that if the Twp. takes over this segment, PennDot will pay the Township to grind, re-gravel, redo apron with macadam. There will no cost to the Twp. It will be a non-maintenance rd. This would be a trail head for the ATV system. Supervisor Erickson made a motion to accept this resolution, second by Chairman Tobias. All in favor. None opposed.

There was no other new business or additional public comment.
